We were just sitting around talking about whatever and he said lets go find Lucille, so we started on our way to Strawberry Farms ~~we stopped~~ I don't remember how far we got to seven. we stopped there and tried buying something but I can't remember if they sold me anything. e ~~we~~ started walking over there and stopped on the boulevard and we were arguing but I don't what about.
